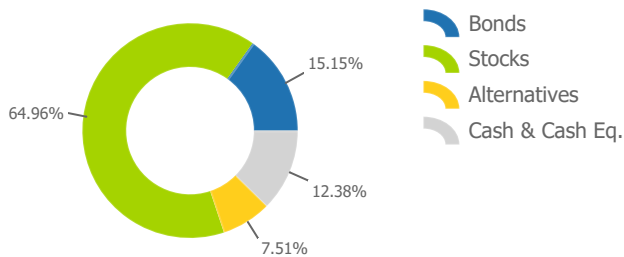
Investment Objective

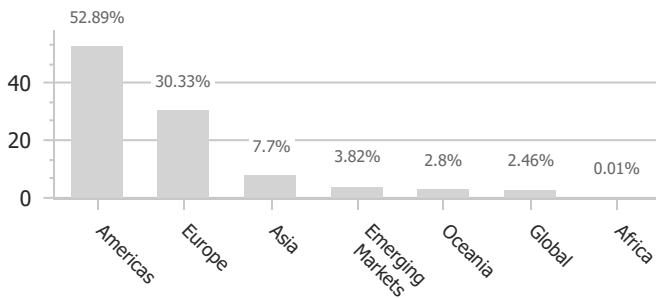

Asset Class Allocation

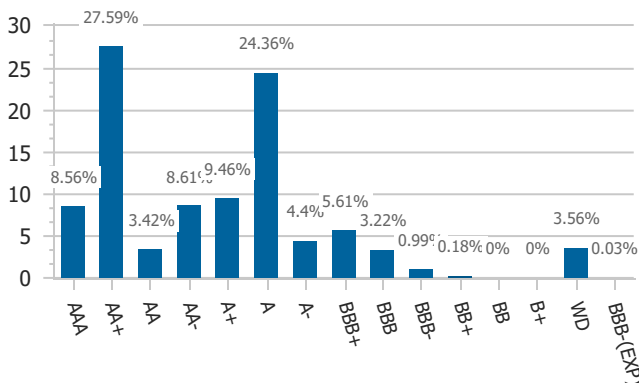


Geographic Allocation



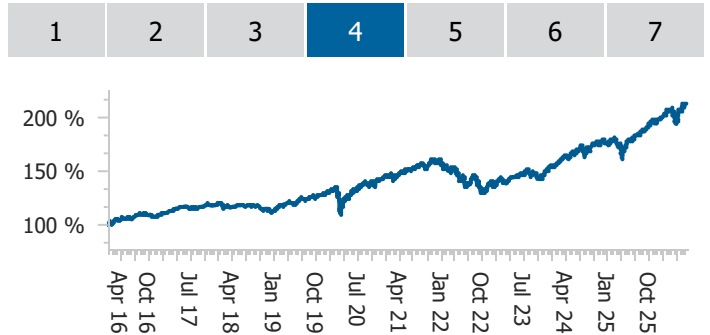

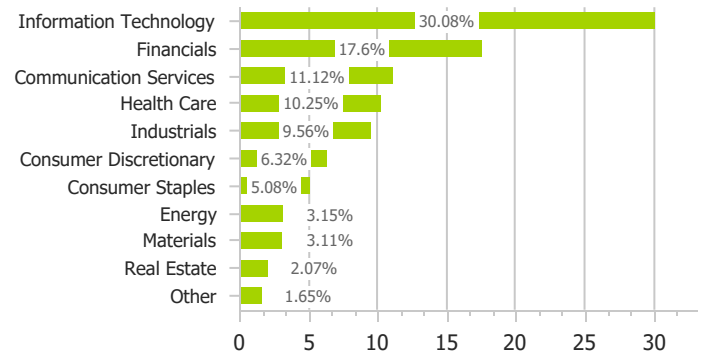

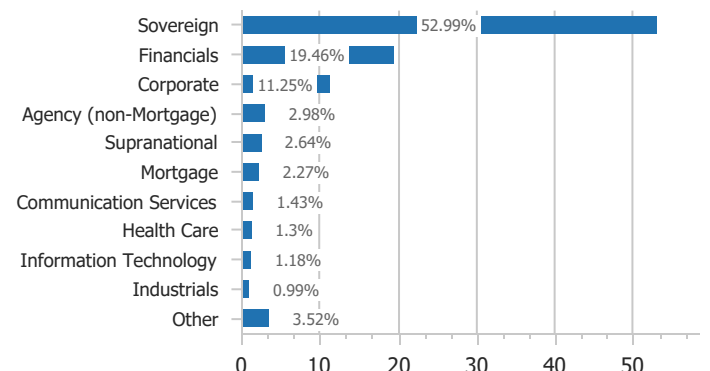
