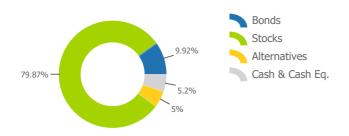

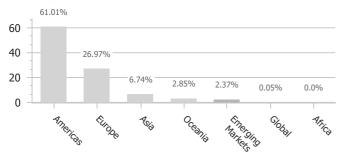

Asset Class Allocation

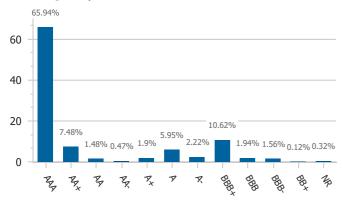


Geographic Allocation

Risk / Reward Scale



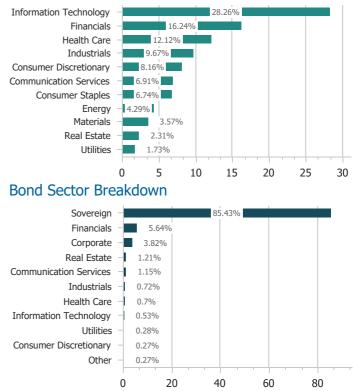
