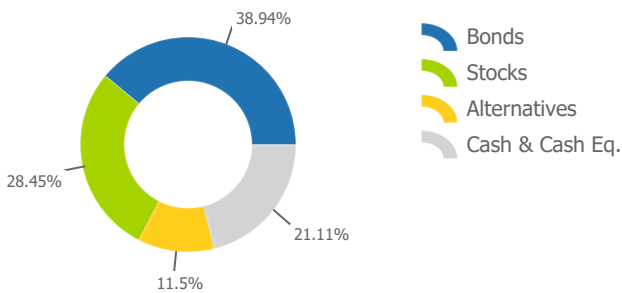
### Investment Objective

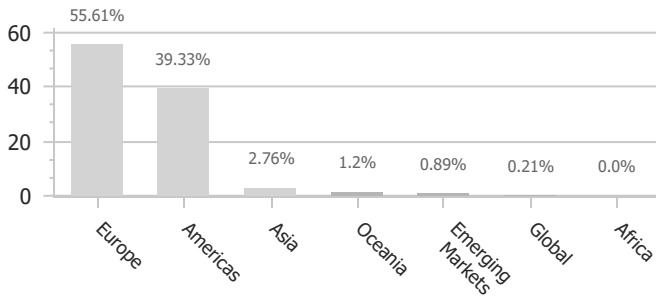

### Asset Class Allocation

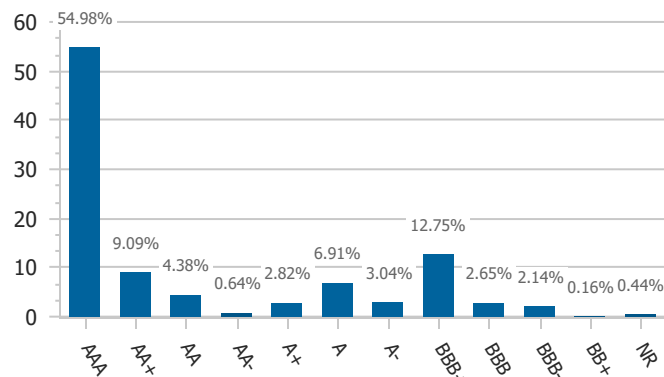


### Geographic Allocation



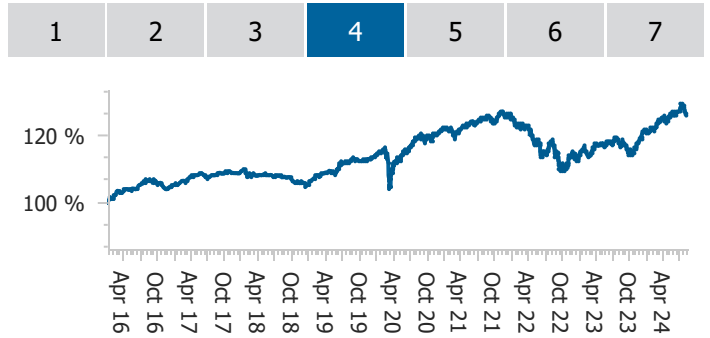

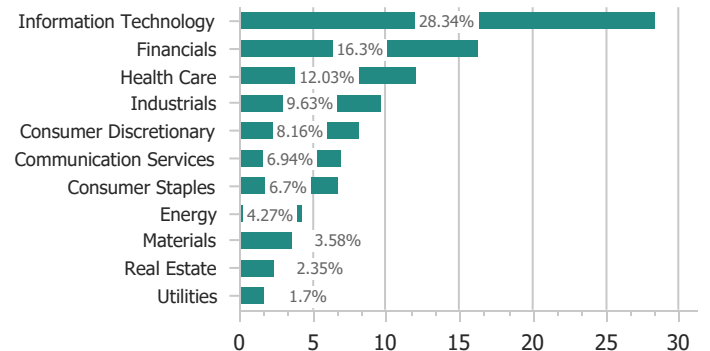

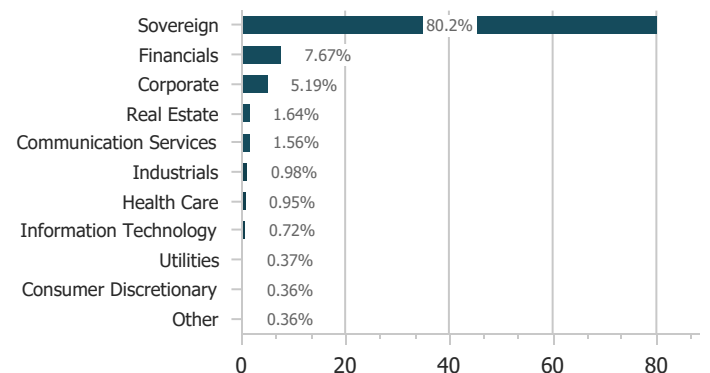
